## Rules and Information Governing Single Registration for Old Dominion Terrier

NOTICE: Dogs with known disqualifications will not be registered (see the ODTCA Breed Standard for a list of disqualifications). To be considered for registration with ODTCA as an Old Dominion Terrier, simply complete this application and submit to The Old Dominion Terrier Club of America (ODTCA) with the following:

- Dog must be at least 6 months of age to submit application for consideration
- A copy of Proof of Registration (please do not submit original)
- □ A copy of at least a 3-Generation Pedigree (please do not submit original)
- Three color photographs of the dog. One from each side and one from the front. All photos should be taken at the dog's level, with the dog in standing position and the tail clearly visible.

#### Fees:

- □ 4-8 dogs.....\$25 each
- □ 9 or more.....\$20 each
